### **SUBJECT:**

Public Works: Approval of amendment to professional services agreement with QK, Inc. of Visalia, CA not to exceed \$928,877 for the design and professional engineering services for the East Lacey Boulevard Pedestrian and Bicycle Safety project from 10th Avenue to east of Sierra Drive; and for design of Traffic Signal at Lacey Boulevard and 9th Avenue.

### **RECOMMENDATION:**

That the City Council by motion:

1. Approve the attached Work Order No. 1 with QK, Inc. of Visalia, CA for Professional Engineering Services for East Lacey Boulevard reconstruction from 10<sup>th</sup> Avenue to east of Sierra Drive, for a cost not to exceed amount of \$869,482.90.
2. Approve the attached Work Order No. 2 with QK, Inc. of Visalia, CA for Traffic Signal Design at East Lacey Boulevard and 9<sup>th</sup> Avenue, for a cost not to exceed amount of \$59,193.33.

### **BACKGROUND:**

This project will involve the widening and reconstruction of East Lacey Boulevard, from 10th Avenue to east of Sierra Drive, to facilitate two lanes in each direction of travel plus a center dual left turn lane. Improvements will include the reconstruction of existing pavement section, installation of a new drainage collection/disposal system including construction of two new drainage basins, installation of curbs, gutters, sidewalks, drive approaches and ADA ramps, additional street lighting, and installation of a traffic signal system at East Lacey Boulevard and 9th Avenue.

This East Lacey Boulevard Preliminary Engineering design project has received grant funding through a Federal Pedestrian Facilities, Active Transportation Program (ATP) and Congestion Mitigated Air Quality (CMAQ) grants. The Traffic Signal design project has received grant

funding through a CMAQ grant and city transportation funds. Grant funding that is currently authorized for the project is for the Preliminary Engineering (PE) phase of the projects.

Preliminary Engineering work includes environmental studies, National Environmental Policy Act (NEPA) approval, CEQA approval, utility investigations and engineering work associated with utility relocation, preliminary design, final design including Plans, Specifications and Estimates (PS&E) and other related work leading the construction of the project. Preliminary Right of Way (ROW) activities include pre-acquisition activities such as estimating, title search, legal descriptions, and preliminary property map preparation and studies as needed for NEPA compliance.

The City has prepared a Design Masterplan for the project that identifies the preliminary alignments, grades, right of way, utilities, tributary areas, storm drainage design and basins. The Consultant will prepare three separate sets of construction documents (PS&E) for East Lacey Boulevard, comprising of a bid ready set of documents.

This project will improve traffic flow capacity and safety by providing additional travel lanes, a protected left turn lane, and the installation of a traffic signal system at the intersection of East Lacey Boulevard and 9th Avenue. Drainage and pedestrian safety will also be improved with the addition of curb, gutter, sidewalks and street lighting.

Attached are Work Orders No. 1 and 2 with QK, Inc. These are an amendment to the City's On-Call Engineering Services Agreements with QK, Inc. that was previously approved by Council on March 29, 2021. The contract work orders specify that all design work and project coordination services will be performed in conformance with the City's existing professional services agreements on a time and material basis at rates set forth in the established fee schedules at a not to exceed cost of \$928,877.

### **FISCAL IMPACT:**

East Lacey Boulevard Pedestrian Facilities project from 10th Avenue to east of Sierra Drive: The Capital Improvement Program (CIP) adopted by Council has appropriated the funding for engineering services for this project. The total cost for design services will be billed on time and materials basis not to exceed \$869,482.90. This project has received Federal Funding from the Pedestrian Facilities ATP grant in the amount of \$44,200 and an additional \$500,000 through CMAQ funding. The design phase is fully funded.

Traffic Signal at East Lacey Boulevard and 9th Avenue:

The Capital Improvement Program provides \$15,193.00 for engineering services for this project. This project has additionally received Federal Funding from the Congestion Mitigated Air Quality (CMAQ) grant in the amount of \$44,000. The total cost for design services will be billed on a time and materials basis not to exceed \$59,193.33. The design phase is fully funded.

Attached are the CIP pages for Council review. At the time of this report there was currently a remainder of \$5,034,000 appropriated for these projects of which the \$928,877 will reduce available appropriation. Upon completion of the design phase, staff will bring these projects back for consideration to go out to bid and a final recommendation for additional appropriation as required for construction.

### 9TH AVE & LACEY SIGNAL

**Project Background:**

This project will involve the installation of a Traffic Signal and Safety Lighting at the intersection of 9th Avenue and East Lacey Boulevard to facilitate four lanes along with turn pockets and traffic signal facilities equipment.

**Existing Conditions:**

East Lacey Boulevard, between 10th Avenue and Sierra Drive is currently a two lane arterial roadway. Current average daily traffic volume is approximately 7,000 vehicles per day. Traffic volumes are anticipated to increase substantially with the continuing development of the regional shopping center, including Costco.

**Project Justification:**

This project will improve traffic flow capacity and safety by providing additional travel lanes, safe pedestrian crossing locations, additional safety lighting, and ADA compliant curb returns with the installation of a traffic signal system at the intersection of East Lacey Boulevard and 9th Avenue.
